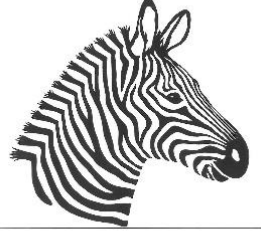

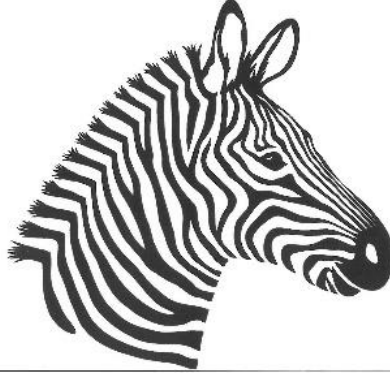

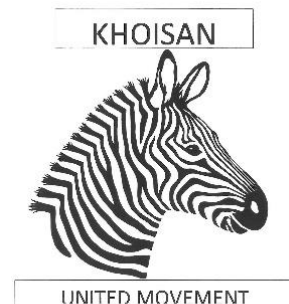

1 PREAMBLE

We believe the Holy Bible to be the inspired, inerrant written word of God and the final authority above all Man's laws and government. We believe civil government is under the authority of God. We believe that biblical principles provide the proper foundations for civil government's role to ensure personal freedom, family values, justice, peace, security, national unity and reconciliation for the nation and its citizens. To provide strong Christian leadership and to defend, promote and uphold Biblical principles in legislation;

We, the Khoisan United Movement (KUM), pledge our Commitment to a unified, democratic, non-racist, non-exploitative South Africa based on the freedoms and securities enshrined in the Bill of rights of the Constitution of the Republic of South Africa. The civic movement is founded on the basic needs, aspirations and expectations of the masses of our people. We believe that our commitment and the attainment of our aims and objectives can only be achieved by a united country with strong governance, an effective civic movement and a vibrant civic society.

We are proud of our history of struggle and the achievement of freedom by the people of our country and the advancement of the values of a democratic state. It is a responsibility to ensure that the freedom that our people won is defended and the values that are enshrined in the Freedom Charter and in the Constitution of the Republic of South Africa are deepened in our society. We shall applaud and contribute to the success of a government that is and remains at all time committed and inspired to implement all measures necessary to achieve, promote and protect human rights and freedoms, as well as eradicate poverty, and ending all forms of discrimination. We believe in the creation of an environment that strengthens civil society and enables its effective participation in government programmes. We are therefore committed to assist to make civil society and government work for all our people in particular, women, youth, the poor and those in rural areas by participating in government and community programmes that are aimed:

- To relieve poverty; to create jobs;
- To promote entrepreneurial opportunities and skills development;
- To protect our people from crime;
- To advance citizen participation in all our communities;
- To ensure constructive delivery of services in communities;

- Protect people's rights as enshrined in the Constitution of the Republic of South Africa especially the protection and advancement of the rights of women, children, the elderly, people with disabilities and the youth;

- To fight for social justice and defend the democratic gains of the people.

2 DEFINITIONS

- 2.1 **Branch** A municipal ward falling within a specific local or district council.
- 2.2 **Constitution** The Constitution of KUM contains the rules and principles that prescribes the rights and duties of its structures and members. It is the basic law of KUM.
- 2.3 **Departments** Human Settlement; Rural development & Land Reform; Agriculture, Fisheries & Forestry; Education; Cooperative Governance & Traditional Affairs, Health; Social Development; Economy Development; Trade & Industry; Tourism; Sports & Recreation; Arts & Culture; State Security; Police; Correctional Services; Women, Youth, Children & Disabled People; Labour; Public Works; Water and Environmental Affairs; others as may be determined by the NEC.
- 2.4 **Executive Committee Member** A person who holds office within KUM, Nationally, Provincially, Regionally or at Branch level.
- 2.5 **Member** A person who has applied for and being accepted as a paid up member of KUM. Persons over 18 years of age may apply for membership.
- 2.6 **National Office Bearers** The National President, the Deputy President, the Secretary General, the Deputy Secretary General, the Treasurer General, and the Organizing Secretary General.
- 2.7 **Province** A geographical area as demarcated in the Constitution of the Republic of South Africa.
- 2.8 **Quorum** The minimum number of officials or members of a structure or committee, usually a majority, who must be present for the valid transaction of the business of the meeting.
- 2.9 **Region** An area which has been determined by the National Executive Committee.
- 2.10 **National Executive Committee** National leaders elected at a National Conference and Chairpersons of Provinces.
- 2.11 **Structure** Either a province; region; branch or a (sub)committee / commission as determined by the NEC.

3 NAME

The name of the organization shall be KHOISAN UNITED MOVEMENT herein referred as "KUM"

4 COLOURS

- 4.1 The colours of KUM shall be black, white, brown, green and red.
- 4.2 The slogan in the logo shall be "Putting people first" which means people for delivery, transformation and growth".

5 CHARACTER OF KUM

- 5.1 The KUM is non-racial, non-sexist, independent unitary civic movement; its policies are determined by the membership and Structures of KUM.
- 5.2 The leadership is accountable to the membership in terms of the procedures laid down in this Constitution.
- 5.3 The principles of freedom of speech and free circulation of ideas and information shall operation within KUM.
- 5.4 KUM consists of the following structures:
 - National Conference
 - National Executive Committee (NEC)
 - National Office Bearers (NOB)
 - National Working Committee (NWC)
 - Provincial Conference
 - Provincial Executive Committee (PEC)
 - Regional Conference
 - Regional Executive Committee (REC)
 - Annual Branch Meeting (AGM)
 - Branch Executive Committee (BEC)

6 NATIONAL OFFICES

The National Office of KUM shall be in Cape Town or at any other city as may be determined by the National Conference. In deciding the National Office of KUM the National Conference shall take onto consideration all other factors relevant in so deciding including but not limited to the costs of relocating the National Office.

AIMS AND OBJECTIVES

- 6.1 The principal aims and objectives of KUM shall be to build KUM into a strong, independent, effective and a comfortable Organization by mobilizing, recruiting, organizing and concretising the people of South Africa with special regard to the poor and marginalized;
- 6.2 Furthermore the aims and objectives of KUM shall be:
 - 6.2.1 To achieve the goals set out in the preamble;
 - 6.2.2 To effect empowerment and capacity – building through projects, programmes, campaigns, education and training;
 - 6.2.3 To represent its members and negotiate on behalf of its members in dealings with other parties, organizations, or authorities on any matter affecting their interest;
 - 6.2.4 To comment on, advance or propose any law, action or policy of any authority affecting the interest of residents;
 - 6.2.5 To institute legal proceedings and any other action on behalf of its members, and to defend residents legal interest, either individually or collectively;
 - 6.2.6 To co-operate with other progressive organs of civil society who have similar aims and objectives;
 - 6.2.7 To form a Trust on behalf of its members, which trust shall be the main shareholder in the KUM investment projects;
 - 6.2.8 To enter into any contracts on behalf of its members with third parties in order to provide benefits for its members;

- 6.2.9 To establish and promote community projects which are in the interest of the community;
- 6.2.10 To do such things that is in the interest of the organisation, its members and communities to ensure accountability and the effective delivery of services;
- 6.2.11 To give assistance of whatever nature to its member which might be deemed necessary.

7 MEMBERSHIP

- 7.1 Membership shall be open to all South Africans irrespective of race, sex, political affiliation, class and geographical location above the age of 18 who accepts the principles and policies of KUM.
- 7.2 All members shall promote the aims and objectives of KUM and be obliged to abide with its constitution and code of conduct.
- 7.3 All members of KUM have to pay an annual subscription fee of R10-00 as determined by the National Conference.
- 7.4 The branch executive committee in consultation with the NWC shall have power to accept or refuse any application for membership. If the BEC does not exist the REC or PEC shall assume responsibility.
- 7.5 Membership cards shall be issued by the NEC to registered members of KUM and to persons whose applications for membership has been accepted, subject to payment of the prescribed subscription fee.
- 7.6 An individual shall cease to be a member of KUM on the happening of any of the following:
 - 7.6.1 If found guilty by court of law for any crime which the NWC shall in its discretion, regard as serious.
 - 7.6.2 If he/she fails to pay his/her subscriptions for six (6) months and after having been so advised in writing.
 - 7.6.3 If he/she dies.
 - 7.6.4 If he/she is expelled from the Organization after a Disciplinary Hearing has been held.
- 7.7 Non-earning members or those with reduced incomes will pay such a fee as determined by the NEC.

8 RIGHTS AND DUTIES OF MEMBERS

8.1 A member has a right to:

- 8.1.1 Take full and active part in the discussion, formulation and implementation of the policy of KUM;
- 8.1.2 Receive and impart information on all aspects of KUM policy and activity;
- 8.1.3 Offer constructive criticism of any resident, official, decision, policy, programme or activity of KUM within the parameters of the code of conduct;
- 8.1.4 Submit proposals or statements to KUM structure
- 8.1.5 Take part in elections and be elected or appointed for any committee, structure or delegation of KUM unless such a member has been suspended or is otherwise disqualified in terms of the provisions of this constitution.

8.2 A member shall have the duty to:

- 8.2.1 Belong to and participate in a branch;
- 8.2.2 Inform his/her branch committee of a change of address to any new area;
- 8.2.3 Explain the aims, principals, policies and activities of KUM to other residents;
- 8.2.4 Combat propaganda detrimental to the interests of KUM;
- 8.2.5 Defend its aims, principals and policies, activities and programmes;
- 8.2.6 Fight against any form of discrimination, racism, sexism and religious intolerance;
- 8.2.7 Deepen his/her understanding of the social, cultural, political and economic problems of his/her city and country as a whole;
- 8.2.8 Take all necessary steps to understand and carry out the aims, policies, programmes and activities of KUM; and
- 8.2.9 Observe discipline, behave honestly and carry out the decisions of the majority and those of higher structure within KUM.

9 ORGANISATIONAL STRUCTURE

The organisational structure of KUM shall be subdivided into provinces, regions and branches/locals, which shall all be answerable to the National Executive Committee.

SAPCO shall consist of the following organs:

- The National Conference, which elects the National Working Committee (NWC)
- The Provincial Conference, which elects the Provincial Working Committee (PWC)
- The Regional Conference, which elects the Regional Working Committee (RWC)
- The Branch Annual General Meeting, which elects the Branch Executive Committee (BEC)

9.1 THE NATIONAL CONFERENCE

The National Conference shall be the supreme ruling and controlling body of KUM and it must be held every after five (5) years.

Composition

9.1.1 It shall be composed of all provincial delegates. The delegation for the Conference shall be proportional to membership of the province and the Formula determined by the NEC.

Power and duties

9.1.2 The National Conference shall:

- 9.1.2.1 Elect the NWC members;
- 9.1.2.2 Decide and determine the policy, programme and constitution of KUM
- 9.1.2.3 Receive and discuss the reports of the NEC which shall include the Presidential address, the General Secretary's report which shall include a report on the work and activities of all other KUM structures;
- 9.1.2.4 Have the right and power to review, ratify, alter or rescind any decision taken by any of the Constitutional bodies, units or officials of KUM;
- 9.1.2.5 Have the power to elect or appoint any commission or committee and assign special tasks and duties to such commission or committee;

9.1.2.6 Elect the National President, Deputy President, Secretary General, Deputy Secretary General, Treasurer General, Organizing Secretary General and the head of departments, the twenty (20) NWC members.

9.2 NATIONAL EXECUTIVE COMMITTEE (NEC)

The NEC shall be the national policy-making body of KUM in between National Conference and shall be vested with the power to decide on policy issues by the Provincial Conferences in line with the national policies and principles of the National Conference.

Composition

9.2.1 The NEC shall be composed of the following:

9.2.1.1 The National Working Committee (NWC);

9.2.1.2 The Chairperson and the Provincial Secretary of each province.

Meetings

9.2.2 The NEC shall ordinarily meet at least once every two months on a date fixed by the National Working Committee. Special meetings of the NEC shall be called by the President upon written requisition of not less than fifty one percent of the provinces.

9.2.3 Carry out the decisions and instructions of National Conference.

9.2.4 Issue and send directives and instructions to and receive reports from provinces.

Powers and duties

9.2.5 the NEC shall:

9.2.5.1 carry out the decisions and instructions of the National Conference;

9.2.5.2 Issue and send directives and instructions to and receive reports from province;

9.2.5.3 Set up sub-committee and determine their nature; membership and scope;

9.2.5.4 Carry out discipline in terms of relevant clauses in this constitution;

9.2.5.5 Establish projects and activities in accordance with Aims and Objectives of the organization;

9.2.5.6 Endeavour to settle disputes within and between structures;

- 9.2.5.7 Dissolve the leadership of the province, region or branch where it deems it necessary;
- 9.2.5.8 Terminate in consultation with the branch the membership of an individual;
- 9.2.5.9 Open and operate a banking account in the name of KUM into which monies raised shall be placed and administer such funds;
- 9.2.5.10 Acquire, either by purchase, lease or otherwise any movable or immovable property belonging to KUM;
- 9.2.5.11 Approve annual audited financial statements and balance sheets of the organization and approve the budget presented by the NWC.
- 9.2.5.12 Appoint any person or persons to fill vacancies within the NEC;
- 9.2.5.13 Appoint NEC members to respective departments for area of focus;
- 9.2.5.14 Right to co-opt three NEC members. Provided names are approved by two-third majority of NEC members;
- 9.2.5.15 The Provincial and Regional structures must hold general council in between terms of office. PEC and REC preceding the General Councils shall decide delegation to the General Councils based on proportionality to membership/

9.3 NATIONAL WORKING COMMITTEE DUTIES

- 9.3.1 Carry out duties as mandated by the National Executive Committee;
- 9.3.2 Shall assume all powers of the National Executive Committee in between National Executive Committee meetings.

9.4 NATIONAL OFFICE BEARERS DUTIES

- 9.4.1 Carry out duties as mandated by the National Working Committee;
- 9.4.2 Shall assume the powers of the National Working Committee in between National Working Committee meetings;
- 9.4.3 Shall be responsible for the day-to-day executive functions of the organisation;
- 9.4.4 Shall be responsible to oversee all commercial investments of the organisation;
- 9.4.5 Appoint Trustees to the KUM Development Trust.

9.5 PROVINCIAL EXECUTIVE COMMITTEES

Provincial Conference

- 9.5.1 Every Province shall hold a tri-annual Provincial Conference.
- 9.5.2 All the affairs of KUM pertaining to a Province shall be decided.
- 9.5.3 The Provincial Conference shall elect the Provincial Executive Committee (PEC).

Composition

- 9.5.4 The PEC shall consist of the provincial Chairperson, Deputy Chairperson, Provincial Secretary, Deputy Secretary, Treasurer, Provincial Organisation Secretary and 15 office bearers who are the Heads of Departments for their Province.

Powers and duties

- 9.5.5 The PEC shall:
 - 9.5.5.1 Be responsible for carrying out the decisions of the Provincial Conference;
 - 9.5.5.2 Organize, establish and service branches in the Province and supervise the work of the regions in the province;
 - 9.5.5.3 Carry out the policy and programme of KUM and do all things necessary to further the interest, aims and objectives of the organisation;
 - 9.5.5.4 Allocate office bearers to their respective departments or area of focus.

9.6 REGIONAL COMMITTEES

- 9.6.1 The PEC, in consultation with the NEC, shall divide the Province into regions for the more efficient and democratic functioning of KUM.
- 9.6.2 The maximum number of regions shall be determined by the PEC in consultation with the NEC.
- 9.6.3 Criteria for Regional demarcation shall be reviewed by the National Executive Committee from time to time.

Annual General Meeting

9.6.4 Each region shall hold bi-annual general meetings.

9.6.5 Additional regional council meetings may be convened by the regional executive committee or the PEC or on the request of at least one-third of the branches.

Composition

9.6.6 The annual general meeting shall elect the Chairperson, Deputy Chairperson, Regional Secretary, Deputy Secretary, Treasurer, and 15 office bearers, who shall have the same functions as the aforesaid office bearers but at regional level.

9.6.7 The regional executive committee shall be accountable for the PEC for its functioning.

Representation at Annual General Meeting:

9.6.8 Each branch shall be entitled to send at least one delegate to the annual general meeting.

9.6.9 Each branch within a region shall be entitled to send delegates to the annual regional meeting in proportion to its members proportional to its membership.

9.7 BRANCHES / LOCAL COMMITTEES

Every member of KUM shall belong to a branch, which shall be the basic unit of the organisation.

Powers and duties

9.7.1 The branch shall:

9.7.1.1 Be registered with the National Office and have a minimum of 40 paid-up members to be constituted;

9.7.1.2 Meet as provided for in the rules and regulations;

9.7.1.3 Be the place where members exercise their basic democratic rights to discuss and formulate policy matters, which shall be recommended to the NEC;

9.7.1.4 Be the basic unit of activity for members;

9.7.1.5 Elect an annual branch meeting, the Chairperson, Deputy Chairperson, Branch Secretary, Deputy Secretary, Treasurer and 5 other office bearers, which shall

have the same functions as some of the regional office bearers, but at a branch level;

9.7.1.6 Meet at least once per month.

9.8 QUORUM

The quorum for each meeting of the Branch Executive Committee shall be 50% + 1 (fifty percent plus one) of the total BEC membership. The quorum for the bi-annual branch meeting and any other branch meetings where the branch makes nominations of candidates for election within KUM or for representatives, or takes decisions relating to policy matters, shall be 50% plus one of the minimum required paid-up members of a branch.

10 PROVINCES, REGIONS AND BRANCHES

- 10.1 This constitution shall be binding on all provinces, regions, branches and all structures of KUM.
- 10.2 The policies, principles and attitudes of the functionaries of all such structures shall not be contrary to the National Policy of KUM.
- 10.3 All such structures shall have on name, i.e. KUM, and one common constitution as adopted by the National Conference of KUM.
- 10.4 The powers and duties at any level of structures and for leadership shall be the same as that of the national structures.
- 10.5 The portfolios, powers and duties of the members shall be the same as those of the province and structures below.
- 10.6 The same principles shall apply to all other structures below the level of the provinces.
- 10.7 The elected provincial executive committee shall report to the full provincial executive committee.
- 10.8 The PEC shall be the policy interpretation body in the provinces.

- 10.9 Provincial departments shall have a head who shall be a member of the PEC. The same principle shall apply to regions, locals and branches and other structures of KUM where applicable.

11 COMPOSITION OF STRUCTURE AT LOCAL LEVEL

- 11.1 All KUM structures at local level shall operate on the same principles as regions but at local level.
- 11.2 Each local shall be a branch as agreed to by the local conference or local general council, whatever the case may be. The structure of such branches shall operate on similar principles but at the level of a branch.
- 11.3 Each branch shall be further sub-divided into areas and such areas into street committee and shall operate on similar principles as other structures.

12 THE NATIONAL WORKING COMMITTEE (NWC)

Composition

- 12.1 The NWC shall be consisted as follows: The President, Deputy President, General Secretary, Deputy Secretary General, Treasurer General, Organizing Secretary General and the elected and co-opted departmental heads.
- 12.2 The members of the National Working Committee shall not necessarily be full-time functionaries of KUM. However, the NEC shall determine the extent to which the elected members shall be full-time functionaries who may be allocated specific responsibilities.

Powers and duties

- 12.3 The National Working Committee shall:
 - 12.3.1 Carry out decisions and instructions of the National Conference and the NEC;
 - 12.3.2 Conduct the current work of KUM;
 - 12.3.3 Submit a report to each NEC meeting;
 - 12.3.4 The NWC shall delegate its powers in between the meetings of the National Executive Committee and the National President and the Secretary General who will take whatever decisions appropriate for KUM on behalf of the National Working Committee.

- 12.3.5 Have the powers to recommend any policy decision of the organisation;
- 12.3.6 Deal with such matters as are specifically delegated to it by the NEC and the National Conference;
- 12.3.7 Facilitate and encourage co-operation between provinces and other KUM structures.
- 12.3.8 Demand and receive reports from regions and other KUM structures;
- 12.3.9 Manage and control all national property and funds for KUM;
- 12.3.10 Convene meetings of the NEC and the National Conference;
- 12.3.11 Issue and send directives and instructions to all other structures of KUM;
- 12.3.12 Discipline any member from the organisation in circumstances in which a member has acted contrary to the aims and objectives and resolutions of NWC, NEC, National Conference;
- 12.3.13 Engage employees of the organisation, and fix their conditions of employment and define their duties based on recommendations from the National Office Bearers;
- 12.3.14 Afford legal and other assistance to all KUM structures and members in furtherance of the aims and objectives of KUM;
- 12.3.15 Institute and/or defend legal proceedings against KUM and to appoint a person to sign any documents with or on behalf of the organisation;
- 12.3.16 Supervise and direct the work of KUM generally; and
- 12.3.17 Ensure that all the structures of KUM function effectively and democratically.

Meetings

- 12.4 The NWC ordinarily meet at least once every six weeks on the date to be fixed by the National President.
- 12.5 Special meetings of the NWC shall be called by the President through the Secretary General upon written requisition of not less than two thirds of the NWC members.
- 12.6 The NWC shall have the power to call a special NEC meeting should it be necessary.

- 12.7 Seven (7) days written notice of the NEC shall be given to each provincial representative provided that the case of a special or urgent meeting, shorter notice may be given of not less than three (3) days.
- 12.8 The quorum of the meeting for the National Working Committee shall be 50%+1 committee members.
- 12.9 If a NWC member does not attend committee meetings for three consecutive meetings, there is a written apology for each meeting before and during the meeting.

13 DUTIES OF NATIONAL OFFICE BEARERS

13.1 The **President** shall be:

13.1.1 A fulltime functionary of the organisation and be:

13.1.2 The head and chief directing officer of KUM at all levels and in charge of the structures of KUM;

13.1.3 Accountable to the NEC for his/her activities and meetings;

13.1.4 Entitled to preside over all meetings of KUM at levels where he/she is elected;

13.1.5 The leader of KUM delegations in meeting with all persons and organizations with whom KUM meets;

13.1.6 One of the signatories of bank accounts of KUM;

13.1.7 Present the executive committee with a comprehensive statement of the state of a nation and political situation generally at relevant levels;

13.1.8 Pronounce for and on behalf of the NEC outlining and explaining the policy or decisions of the organisation on any matter;

13.1.9 Be an ex office member of all committees at all levels of the organisation

13.2 The **Deputy President**

13.2.1 Shall deputise for the President when necessary and carry out whatever functions are entrusted to him or her by the National Conference, the President or the NWC.

13.3 The **Secretary General** shall:

13.3.1 Become a full time functionary of the organisation;

13.3.2 Be responsible for all administrative aspects of KUM at the appropriate level / structures where they are elected;

13.3.3 Keep in touch with all administrative aspects of KUM and brief the President and Deputy President of all such relevant matters;

13.3.4 Call meetings of KUM and be responsible for the distribution of minutes and all other relevant documentation to the Executive Committee and other structures of KUM;

13.3.5 Attend all meetings of KUM and be responsible for the minute-taking at all meetings;

13.3.6 Head the administration, co-ordination and commercial departments and shall receive reports from all departments, staff and all structures of KUM;

13.3.7 Submit to the annual general meeting and conference, an assessment and evaluating report on the performance and external impact. The report shall be prepared by an independent body;

13.3.8 Issue press statements and deal with the media to make KUM's aim and objectives, policies and principles known to the public, on behalf of and on instruction of the President;

13.3.9 In the absence of the President and the Deputy President the Secretary General shall assume the functions of the President.

13.4 The **Deputy Secretary General** shall:

- 13.4.1 Deputise KUM media and publicity department;
- 13.4.2 Deputise the Secretary General;
- 13.4.3 Liaise with the news agencies, newspapers and other media on behalf of KUM; and
- 13.4.4 Be responsible for performance of departments;
- 13.4.5 Issue press statements and deal with the media to make KUM's aim and objectives, policies and principles known to the public on behalf of and in consultation with the Secretary General.

13.5 The **Treasurer General** shall:

- 13.5.1 Be responsible for all aspects related to the financial affairs of KUM;
- 13.5.2 Co-ordinate fundraising activities and efforts;
- 13.5.3 Liaise with founders at the level where he/she has been elected;
- 13.5.4 Maintain proper book of accounts and monitor bank accounts for KUM;
- 13.5.5 Submit regular written reports to the NEC and NWC regarding the financial position of KUM at his/her level;
- 13.5.6 Be head of treasury and finance together with all treasurers of structures below and one he/she is elected in;
- 13.5.7 Be chief custodian of the funds and property of KUM;
- 13.5.8 Submit to conference, an independently audited financial statement covering the period as may be determined by the conference, or executive committee, from time to time.

13.6 The **Organizing Secretary General** shall:

- 13.6.1 Be responsible, with the National Organizing Department, for working out and executing plans for the Organising Department;
- 13.6.2 Supervise and direct the work of the National Organising Department and consult on issues with the President;
- 13.6.3 Submit periodic reports to the NEC and NWC.

14 ELECTIONS AND VOTING

- 14.1 Nomination procedures and conduct of elections shall be made by resolution of NEC, REC, and BEC preceding the election conference.
- 14.2 All KUM structures shall vote through a secret ballot.

- 14.3 Independent electoral officers shall be appointed by the NEC to conduct national elections. Elections of all structures below shall be conducted by the immediate higher structure.
- 14.4 Each member shall be entitled to one-person-one-vote.
- 14.5 At a national provincial and regional level only mandated delegates and the executive committee shall be entitled to participation in elections and voting.
- 14.6 No interim structure shall have voting rights and no person from an interim structure shall be eligible to be voted for, at higher level.

15 KUM EMPLOYEES

- 15.1 KUM shall adopt an employment code, which will govern conduct of all staff employed by the organisation.
- 15.2 The conduct of any KUM employee shall be guided by the rules and regulations as laid in the code of employment.

16 CODE OF CONDUCT

- 16.1 The code of conduct, disciplinary guidance, policies and resolutions of KUM shall be binding on all members.
- 16.2 The relationship between Civic Committee Members shall be as follows:
- 16.3 When a committee member has made a mistake, the member will be dealt with internally before the issue is brought to the attention of the disciplinary committee;
- 16.4 No member of KUM shall be insulted or treated in a disrespectful manner by another member;
- 16.5 Character assassination, gossiping and destructive criticism is not allowed;
- 16.6 No member of any committee of the civic shall criticize another member outside a meeting or publicly;
- 16.7 The conduct of any member shall be such that he/she complies with the aims and objectives, principles and policies and the constitution of the organisation;
- 16.8 A member shall be disciplined, obedient and loyal to KUM at all times;
- 16.9 Members in general should also be bound by the rules and regulations as in clauses 19.2 of this constitution;
- 16.10 Any KUM member who behaves himself or herself contrary to the Code of Conduct shall be subjected to discipline.

Rules and Regulations

- 16.11 The following rules and regulations shall be observed by all KUM members:
 - 16.11.1 Drug taking is not allowed and excessive drinking is discouraged;
 - 16.11.2 Abusive and disrespectful behaviour towards other people is prohibited;
 - 16.11.3 Gossiping maliciously so as to set one member against other shall constitute misconduct;
 - 16.11.4 Behaving in a manner calculated to bring KUM into disrepute will be regarded as misconduct;
 - 16.11.5 Unauthorized use of KUM property for personal advantage is not allowed;

- 16.11.6 Discrimination on the basis of race, political affiliation, ethnic origin, sex and religion is prohibited;
- 16.11.7 Disrupting meeting and interfering with the orderly functioning of the civic shall be regarded as misconduct.

17 PENALTY FOR MISCONDUCT

- 17.1 There shall be a disciplinary committee to keep discipline amongst members.
- 17.2 Disciplinary proceedings shall be confined to violation of the basic principles and policies of the civics as well as the rules and regulations hereof.
- 17.3 Review and appeal proceedings shall be conducted at the level where the violation has occurred or the NWC might move the hearing to a higher level than where the hearing took place.
- 17.4 Any person faced with disciplinary proceedings shall receive due notice of any hearings and the basic allegations against him/her.
- 17.5 Such as person shall be afforded a reasonable opportunity to prepare his/her defence.
- 17.6 Any specific person adversely affected by the outcome of any hearing shall have the right to have the matter reviewed by the committee set up by the NWC of KUM.
- 17.7 In case of persistent breach of rules and regulations, suspensions and expulsion from KUM shall be considered.

18 DISCIPLINARY HEARINGS

- 18.1 Any member who contravenes the provisions of this Constitution shall be subjected to disciplinary proceedings by the BEC, REC, PEC and NEC, shall in addition, take whatever decision it deems appropriate under the circumstances against any member who is found guilty of having contravened the provisions of the Constitution.
- 18.2 Any person faced with Disciplinary proceedings shall receive written notice of the hearing, which written notice shall contain the allegations against the said member and shall be given not less than fourteen (14) days before the scheduled hearing.

- 18.3 At the disciplinary hearing the said member shall be afforded a reasonable opportunity to present her defence including an opportunity to address the committee on mitigating factors.
- 18.4 Disciplinary proceedings may also be brought against any member who brings the organisation into disrepute or manifests a flagrant violation of the moral integrity expected of members.
- 18.5 Any member found guilty during a disciplinary hearing shall have the right to appeal within twenty-one (21) days to the immediate higher structure. The NEC shall be the final appeal structure.
- 18.6 Any member suspended for a period exceeding sixty (60) days without a hearing, the suspension will automatically fall away.

19. SPECIAL COMMITTEES AND SUB-COMMITTEES

- 19.1 The executive committee shall be empowered to appoint special committees or commissions when necessary for the benefit of KUM.
- 19.2 The executive committee shall be empowered to appoint or co-opt members should vacancies occur for special tasks of KUM or for replacement of a member who has ceased to be functional at his/her respective level or sub-committee or department, subject to dismissal if necessary by the relevant constitutional structure, the National Executive Committee, Provincial Executive Committee, the Regional Executive Committee or the Branch Executive Committee.

20. INDEMNITY

- 20.1. KUM is a National Unitary Structure but for the purpose of financial transaction and contracts with financial implications, KUM, its provincial structures and their sub-structure are separate and independent entities.

- 20.2. The national office's employees, its bearers and its members are hereby indemnified in their personal capacities from all debts or financial obligations or contracts with financial implications entered into by KUM, its provincial structures and their sub-structures.
- 20.3. The KUM National Office can be held liable for debts, financial obligations or contracts entered into by itself and not for any debts or financial obligations or contracts entered into by the provincial structures or lower structures unless and until the debts or financial obligations or contracts entered into by the provincial structures or sub structures had been consented to and ratified by KUM National Office in writing.
- 20.4. The indemnification shall be applicable to structures and the lower structures for all debts, financial obligations and contracts entered into by KUM Office Bearers formally.

21. CONTRACTUAL LIABILITY

- 21.1. KUM shall be civic organisation with perpetual succession, capable of acquiring rights and obligations, entering into legal transactions and of suing and being sued in its own name.
- 21.2. Only the National Officials shall have the authority to bind KUM or to create any legal relationship.
- 21.3. KUM shall operate bank accounts acquire and own property in its own name.
- 21.4. An office bearer of KUM is indemnified and cannot be held legally liable if acted within the scope of his/her duties, unless acted deliberately and/or with gross negligence.
