PRINCIPAL TRADITIONAL LEADER

In terms of Traditional Leadership and Governance Framework Amendment Act 2009 (Act 23 of 2009), the structure of the institution of traditional leadership comprises of different levels of traditional leadership spread across eight provinces namely; principal traditional leadership; senior traditional leadership and headmen/headwomen. These traditional leadership levels are guided by the principle of customs and tradition. In terms of section 2A (1) of the Framework Act as amended, subject to subsection (2), a number of traditional communities that are grouped together may be recognised as a principal traditional leader

With the implementation of the khoisan traditional leadership bill on 01 April 2021 and the appointment of the Khoisan Commission on 01 September 2021, khoisan traditional leaders and communities was given the opportunity to apply for recognition as senior khoisan traditional leader or branch head and recognition for khoisan communities as from 30 March 2022. On 24 July 2023. I attended an interview investigation with the khoisan commission in Johannesburg, Southern Sun International Hotel. After submitted all the outstanding evidence identified during the interview investigation. I am currently in the process **FOR** recommendation as a senior khoisan traditional leader for Pollsmoor/Westlake/Steenberg communities representing the Hessequa Khoi Tribal Council as the broader council.

Before the death of my brother I was appointed by him to lead as the paramount chief of the Hessequa Khoi Tribal Council as a family member. My customary title as Paramount Chief of the Hessequa Khoi Tribal equal that of principal traditional leader.

1. Based on my international credentials and recognition as paramount by United Global Kingdoms I hereby apply to khoisan commission to recommend me for the customary title of principal traditional leader. I am aware that the scope of mandate of the commission is to focus on recognition of khoisan communities, recognition of senior khoisan traditional leaders or branch heads. The Hessequa Khoi Tribal Council has 25 Communities who applied for recognition to the khoisan commission.
2. With a recognised traditional council with a defined area of jurisdiction in terms of applicable provincial legislation;
3. each have a senior traditional leader recognised in terms of the applicable provincial legislation;
4. recognise a recognised senior traditional leader, who is of higher status than the other senior traditional leaders in terms of custom and customary law, as their principal traditional leader;
5. recognise themselves as a distinct group of traditional communities separate from principal traditional communities and all other traditional communities; and
6. Have a system of traditional leadership at a principal traditional level.

Attached see proof of recognition globally for myself as paramount chief and the Hessequa Khoi Tribal Council

Please take note, I also applied to the South African Qualifications Authority (SAQA) for evaluation of foreign qualification (Doctor of Business Administration – majoring in criminology) obtained via Northwest International University registered with the Ministry of Education Amenia.


