



MEMBERSHIP

All Nations Outreach Christian Council issues four types of ministerial membership status. The type of credential issued is based upon membership status they apply to become a full member.

Credentials are valid for a period of 12 months after which time members must renew their credentials annually.

1. **Affiliate Membership:** For anyone who has a definable full or part-time ministry such as the pastor of a local church, apostle, prophet, evangelist, teacher, and evangelist. Membership in the network is for those who are already ordained through other organizations or ministries but would like to be a part of All Nations Outreach Christian Council stands for and is ministries. Even leaders who are not yet ordained but they lead establish ministries will be able to participate as a full member, and network with other like-minded and like hearted ministers.
